- The constitution of India recognized the right to water as being a part of the Right to Life under article 21.
- This means that it is the right of every person, whether rich or poor to have sufficient amount of water to fulfill daily needs at a price they can afford.
- There should be "Universal access" to water.
- 16 . Why should the government bear the responsibility to provide public facilities to everyone?
 - If private companies are given the responsibility to provide public facilities such as water, they will charge more.
 - In such a situation only, some people can afford to buy water.
 - Thus, even though private companies are providing the facility of water, but this facility is not available to all at an affordable rate.
 - If we go by the rule that people will get as much as they can pay for them many people who cannot afford to pay for such facilities will be deprived of the opportunity to live a decent life.
 - Obviously, this is not a desirable option. Public facilities relate to our basic needs.
 - The Right to Life that the Constitution guarantees is for all person living in this country. Therefore, it should be the government's responsibility to provide public facilities to all.
